INTRODUCTION

METHOD OF ENTRY:

To enter the Giveaway, a Participant must scan the QR code at the event or visit the contest page at sterling.com/contests and complete the online entry form. The form requires participants to provide their first and last name, email address, telephone number, and employer information ("Company").
